

MANUFACTURER'S LIMITED PRODUCT WARRANTY

EZ SOLAR warrants to the buyer ('Buyer') of EZ Solar's PV rooftop junction boxes, designed and manufactured by EZ Solar ('Products') shall be free from defects in material and workmanship which substantially impair their ability to perform their intended purpose provided that the Products were installed in accordance with EZ Solar's written installation instructions.

Limited Warranty Period

This Limited Warranty covering performance of the Products is made for twenty-five (25) years from the earlier of; 1) the date of the installation of the Products is completed, or 2) thirty (30) days after the purchase of the Products by the original Buyer.

If within such a period any such goods shall be proven to EZ SOLAR's satisfaction to be so defective, then and in that event the enclosure shall be repaired or replaced at EZ SOLAR's option. Such correction or replacement of defective goods shall constitute a fulfillment of all liabilities in respect to such goods. Any such repair or replacement does not cause the beginning of new warranty terms, nor shall the Warranty Period of this Limited Warranty be extended. This warranty will only apply if the covered product is installed, operated and maintained strictly in accordance with EZ SOLAR's written installation manual. This warranty does not cover damage to the Product that occurs during its shipment, storage, installation or use, or from force majeure acts including fire, flood, earthquake, storm, hurricane or other natural disaster, war, terrorist activities, acts of foreign enemies and criminal acts.

Transfer of Limited Warranty

Buyer may transfer this Warranty to subsequent Site owners, or if original Buyer is a contractor to the Site owner, so long as the transferee agrees to the terms of the Limited Warranty as if it were the Buyer. Proof of purchase is required for any warranty claim.

Further Exclusions

Any implied warranties covering Products including any warranties of merchantability or fitness for a particular purpose are expressly excluded. There are no warranties which extend beyond the description on the face hereof. EZ Solar shall not in any case be liable for special, incidental, consequential, indirect or other similar damages even if EZ Solar or its agent has been advised of the possibility of such damages. EZ Solar shall not be liable for loss of use, revenue or profit, or for direct, indirect, special, punitive, liquidated, incidental or consequential, damages, or for any other loss or cost of a similar type, or for claims by buyer for damages of buyer's customers, claims of third parties or injury to persons or property arising out of any defect or nonconformity in the product covered by this warranty, even if caused by the negligence of EZ Solar. All damages and expenses are hereby excluded.

In no case shall EZ Solar's aggregate liability exceed the purchase price paid for the defective Products. Such repair or replacement shall be Buyer's sole remedy and shall fulfill all of EZ Solar's obligations with respect to the Product and all warranty claims.

How to Make a Warranty Claim

If Buyer has a claim for repair or replacement under this Limited Warranty, Owner must contract EZ Solar as soon as possible and under no circumstances later than 30 days after the end of the applicable Limited Warranty Period to initiate the Limited Warranty claims by emailing: info@ezsolarproducts.com. Any claim under the above Limited Warranty must include proof of the date the Product installation was completed or the date of original Product delivery such as a copy of Buyer's receipt or Invoice.
