WALLBOX STATEMENT OF LIMITED WARRANTY

Wallbox USA Inc. ("Wallbox") provides an electronic vehicle charging solution for home and business users. It includes an intelligent charging hardware device and an online service for control of the charging functions of the device that is accessible locally on a network and remotely through the Internet via a website and a mobile application.

This statement of limited warranty applies to the intelligent charging hardware device and related accessories ("Equipment") provided by Wallbox.

1. <u>OTHER RIGHTS YOU MAY HAVE</u>. ALTHOUGH THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS, YOU MAY HAVE OTHER RIGHTS IN YOUR JURISDICTION. THIS STATEMENT OF LIMITED WARRANTY IS SUBJECT TO APPLICABLE LAWS THAT APPLY TO YOU AND THE EQUIPMENT. PLEASE REVIEW THE LAWS IN YOUR JURISDICTION TO UNDERSTAND YOUR RIGHTS FULLY.

2. <u>Who is Covered by Wallbox's Limited Warranty</u>. This statement of limited warranty covers users of the Equipment—either individuals who purchased Equipment from Wallbox or one of its authorized resellers or distributors, or who received Equipment as a gift from such a purchaser.

3. <u>Limited Warranty Coverage</u>. For a period of three (3) years from the date of your purchase, Wallbox warrants that the Equipment shall be free from defects in material and workmanship under normal use and service.

4. <u>Warranty Benefits</u>. If, during the applicable warranty period, the user returns defective Equipment to Wallbox, accompanied by Wallbox's return authorization form, and Wallbox's examination of such Equipment discloses to Wallbox's satisfaction that such products are defective and such defects are not caused by abuse, misuse, neglect, alteration, improper installation, repair, improper testing, accident, natural disaster, or use contrary to any instructions issued by Wallbox, Wallbox shall, at its sole option, either repair, replace, or refund to the user the lesser of the standard retail purchase price of such Equipment or the purchase price you paid as shown on your proof of purchase. No Equipment may be returned to Wallbox without Wallbox's returned authorization form.

5. <u>Obtaining Limited Warranty Service</u>. For warranty service, contact Wallbox for shipping instructions and a return authorization form at Service.NA@wallbox.com. Please ship the Equipment to Wallbox with proof of purchase, which is required in order to obtain repairs, replacement, or refunds under this statement of limited warranty. The user will need to pay for shipment of the Equipment to Wallbox. Wallbox will pay for the shipment of any repaired or replacement Equipment.
